Mayor Reece called meeting to order at 6:00 pm. Renihan made a motion to approve the agenda, Gleason 2nded, MC. Schafer made a motion to approve the minutes with correction to note a 2 nd by Hanson to the motion to forward legal counsel a municipal infraction at 406 Quince. Motion to approve minutes with the correction was 2nded by Gleason, MC

Resignation and Oaths of Office - Hanson made a motion to accept Gleason's resignation letter, Schafer 2nded, MC.

Oaths of office for incoming mayor and 3 new council members were read and signed by each elector; Scott Gleason, Darin Tool, Lynn Cave, and Mellissa Berends. Terms will commence 1/1/26.

Citizens' Concerns

Old Business

Nuisance Abatements – 407 Pear St. did move the violating vehicle in the garage after discussion with mayor and council member. Legal counsel was contacted to move forward on the nuisance abatement at 406 Quince St. Municipalities may be able to with an ordinance in place to file fines up to \$700 on properties that don't respond after multiple requests. League of Cities will be contacted to inquire, clerk will advise. Council member will also stop by and see if they can get some action.

Tree at 405 Pear St. Huen says he owns property, but final paperwork hasn't been done. Mayor offered to help cut tree down. The tree at 112 Walnut also needs to be addressed, council member has discussed with homeowner. Will be revisited in the spring.

Question was asked if we have an ordinance that addresses parking on the street when snow removal is done. Ordinance is 66.10. It will be added to the website and on the water bills.

Brochure looks good, mayor pro tem will be added next month and the brochure will be included in a future water bill. Books of Ordinances will be turned over to the city clerk so they can be up-

dated if needed. Clerk will distribute to new council members before the 1 st of the year or sooner if ready.

New Business –

Holiday Decorations – Has been difficult for mayor and council members to get decorations up, going forward there is an option for a contact with Alliant to help do this. The hardware is helping with the decoration that fell and needs to be repaired, they'll also remount.

<u>Dirt at Intersection of Orange and Apple</u> – in the spring this will be corrected as well as the low spots at 205 Orange from the water break. Council wants to clean up the old gravel and asphalt by the water tower at the same time, keep some rock and move to the back. Gleason wants to look into those concrete barriers. Also put in some concrete pads. Gray may have some slabs that he doesn't need. Will be added to March agenda. The fencing was picked up by city resident and put to good use. City should add new posts on corners to prevent encroachment.

Open Meeting Law Training – Mandatory for incoming members, recommended for existing members. Melissa Berends says she has information on no cost courses and will forward so it can be shared.
